UNLIMITED CLIENT HOSTING LICENSE AGREEMENT rev. 2, April 14th 2021

This license agreement is a binding agreement between You and jsPlumb. It contains the terms and conditions for Your use of jsPlumb Toolkit. By installing, copying or otherwise using the Software, You are agreeing to be bound by the terms and conditions of this Agreement.

1. DEFINITIONS

Affiliate in relation to any Person (including a party to this Agreement), any Person directly controlling, controlled by or under common control with such other Person at any time during the period for which the determination of affiliation is made and for the purposes of this Agreement, “control” shall mean in relation to any Person, the power to direct the management or policies of that Person directly or indirectly through the ownership of voting securities, by contract or otherwise.

Agreement means this license agreement.

Applications means the software applications developed by You that use the Software.

Competing Products means any Applications which are not significantly different from the Software or which do not do anything materially different than what the Software does.

Intellectual Property Rights means (i) rights in patents, registered designs, design rights, trade marks, copyright, databases, moral rights, topography rights, and trade and business names, including the benefit of all registrations and applications to register any of the aforesaid; (ii) rights in the nature of unfair competition rights and rights to sue for passing off; and (iii) all trade secret confidentiality and other proprietary rights, including all rights to know-how and other technical information.

jsPlumb means JSPLUMB PTY LTD

Obfuscated Source Code means the obfuscated form of the Source Code or of a modified version of the Source Code. The Source Code is obfuscated if all whitespace and comments are removed and all variables and function names are replaced by meaningless names.

Person means any individual, corporation or body corporate, partnership, association, trust or other entity or organisation, including that person’s legal personal representatives, successors and permitted assigns.

Software means the jsPlumb Toolkit which consists of its Source Code (both obfuscated and unobfuscated) and Documentation.

Source Code means the Javascript source code of the Software.

You means an individual or entity exercising rights under this Agreement or any Affiliate.

2. LICENSE GRANT

Subject to the payment of the fee required and upon acceptance of the terms and conditions of the Agreement, jsPlumb grants You a non-exclusive, perpetual license to exercise the rights in the Software as outlined below:

- a. The Software is licensed per developer. You may make copies on more than one computer, as long as the Software is used by a single developer. If You have purchased a multi-developer license, You may use a copy of the Software identified in the multi-developer license on the number of computers associated with the multi-developer license. The license is per seat and not per named user.
- b. The Source Code is provided to You so that You can create modifications under the terms of this Agreement. You are entitled to use modifications of the Source Code in Your Applications.
- c. You may use the Software on a royalty-free basis as part of any of Your Applications that are hosted by You. However, You may, in a public facing application, use only the Obfuscated Source Code.
- d. You may distribute the Software in any of Your Applications, either in downloadable or embedded form, or to be hosted by some other entity.
- e. You may distribute only the Obfuscated Source Code.

3. RESTRICTIONS

The license granted above is expressly made subject to and limited by the following restrictions:

- a. Subject to Clause 7(b) You may not assign, sublicense, sub-contract, lease, rent or otherwise transfer this Agreement, or any rights or obligations under it, without jsPlumb's prior written consent.
- b. You must not repackage the Software for sale as a Competing Product.
- c. Subject to Clauses 2(b) and (c) You shall treat the Source Code as secret and confidential and under no circumstances will You distribute, disclose or otherwise make any portion of the Source Code or any modified version of the Source Code to any Person, except an Affiliate or third party consultant to provide the modifications to, maintenance of and support for the Software provided the Affiliate and third party consultant are bound by appropriate and legally binding written confidentiality and non-use obligations.
- d. You may not expose the jsPlumb Toolkit API in Your Applications.

4. INTELLECTUAL PROPERTY

The Software is licensed, not sold. You acknowledge that any and all Intellectual Property Rights that subsist in or arise in connection with the Software or the Documentation anywhere in the world and the JSPLUMB trade mark belong to jsPlumb and that You shall have no right in or to the Software or the Documentation or the JSPLUMB trade mark, except for the right to use it as permitted by this Agreement.

You must keep intact all copyright notices for the Software and all notices that refer to this Agreement with every copy of the Software You distribute or publish.

5. LIMITED WARRANTY, DISCLAIMER OF WARRANTIES AND LIMITATION OF LIABILITY

- a. Limited Warranties
 - i. JsPlumb warrants that it is not aware of any facts upon which suggest that the Software infringes any third party patent, copyright or design right.
 - ii. JsPlumb warrants that the Software, as updated and when properly used, will perform substantially in accordance with the accompanying Documentation and the Software will be free from defects in materials and workmanship, for a period of ninety (90) days from the date of receipt. This Limited Warranty is void if failure of the Software has resulted from

accident, abuse, or misapplication. Any replacement Software will be warranted for the remainder of the original warranty period or thirty (30) days, whichever is longer.

- iii. JsPlumb warrants that as provided the Software does not contain any malicious code inserted to affect the functioning of the Software or any computer that the Software runs on. Any developer using JsPlumb must have a broad understanding of security issue relating to web application and must take all reasonable steps at a system level to mitigate those risks.

b. Disclaimer of Warranties.

The foregoing express warranties are limited to jsPlumb and are not transferable and are in lieu of any other warranty by jsPlumb with respect to any products or services furnished hereunder. JSPLUMB GRANTS NO OTHER WARRANTY, EITHER EXPRESS OR IMPLIED, INCLUDING WITHOUT LIMITATION, WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.

c. Limitation of Liability.

SUBJECT TO CLAUSE 5(a) IF JSPLUMB BREACHES ANY PROVISION OF THIS AGREEMENT, JSPLUMB'S SOLE AND EXCLUSIVE MAXIMUM LIABILITY, WHETHER BASED IN CONTRACT, TORT, OR OTHERWISE, SHALL NOT IN ANY EVENT EXCEED THE PURCHASE PRICE FOR THE PARTICULAR PRODUCTS.

6. TERMINATION

Without prejudice to any other rights, jsPlumb shall have the right to terminate this Agreement if You fail to comply with the terms and conditions of this Agreement. Upon termination of this Agreement, all rights granted to You hereunder shall terminate automatically and You will immediately cease use and distribution of the Software.

Subject to the above terms and conditions, the license granted here is perpetual (for the duration of the applicable copyright in the Software). Notwithstanding the above, jsPlumb reserves the right to release the Software under different license terms or to stop distributing the Software at any time, provided, however this will not serve to withdraw this license, and the license granted here will continue in full force and effect unless terminated as stated above.

7. MISCELLANEOUS

a. Entire Agreement

This Agreement constitutes the entire agreement and understanding between the parties with regard to its subject matter and supersedes all prior oral or written agreements, representations, understandings or arrangements between the parties relating to the subject matter of this Agreement. Any amendment to this Agreement must be made in writing and signed by the duly authorised representatives of each party.

b. Assignment

The provisions of this Agreement will be binding upon and shall inure to the benefit of the parties, their successors, and permitted assigns. Neither this Agreement nor any rights under this Agreement may be assigned, pledged, delegated or otherwise transferred by either party, in whole or in part, whether voluntary or by operation of law (including any direct or indirect change in the ownership or control of such party, sale of assets, merger or consolidation), without the prior written consent of the other party, except as follows:

- i. Either party may assign this Agreement to its Affiliate, provided that such party shall remain jointly and severally liable with such assignee for all of its obligations hereunder.
- ii. Either party may assign this Agreement in connection with the sale of all or substantially all of its assets.

c. Governing Law

This Agreement shall be governed and construed in accordance with the laws of New South Wales, Australia and both parties hereby submit to the exclusive jurisdiction of the Courts of New South Wales, Australia.

d. Survival

Clauses 1, 3, 4, 5, 6, 7 will survive the termination of the Agreement. Any other terms of this Agreement that are either expressed so as to survive (or are capable of surviving) termination of this Agreement or from their nature or context it is contemplated that they are to survive termination, shall remain in full force and effect notwithstanding termination.
